STUD FEE & FEES

- 1) BOOKING FEE \$500.00; this is NON REFUNDABLE.
- 2) 2020 STUD FEE \$2,000.00 for registered Gypsy Vanner mares; the booking fee is credited towards stud fee. The stud fee is nonrefundable & nontransferable to another Owner.
- 3) 2020 STUD FEE \$1,500.00 for non-Gypsy Vanner mares; the booking fee is credited towards stud fee. The stud fee is nonrefundable & nontransferable to another Owner.
- 4) The first overnight cooled semen shipment is included with the stud fee; 2nd and subsequent overnight shipments are to be paid in full by Mare Owner.

PRIOR TO SHIPMENT:

- 1) NOTIFY Crystal Lyons when the mare foals or when she first comes into heat; this will alert us that you will be in need of semen soon.
- 2) Expected breeding date is _____.
- 3) The signed contract and ALL FEES MUST BE PAID IN FULL; along with all paperwork must be submitted prior to shipment.

GUARANTEES:

- 1) In the case of poor quality semen, a veterinarian must contact the Stallion Owner with a report before a new shipment will be sent. The Stallion Owner saves samples for examination and comparison of what is shipped. Crystal Lyons will send a follow up shipment at no cost to the Mare Owner if the sample checks out dead.
- 2) In the case the stallion dies or becomes sterile, Crystal Lyons will refund the stud fee.
- 3) In the case the mare is unable to conceive or dies, the Mare Owner has the option to use a replacement mare during the contract, or the following breeding season. No breeding will be held for more than one year, or the contract becomes null and void.
- 4) A LIVE FOAL GUARANTEE is one that lives for 30 days after birth.

LEGAL AGREEMENT:

- 1) In the case of ANY DISPUTES or breach of contract, Texas law will preside as this is a Texas sale. Therefore it is agreed that any legal action will take place in a McCullough County, Texas court of law.
- 2) It is also agreed that in the case of any litigation, if the judgment is in favor of the Stallion Owner, all of the Stallion Owner’s legal fees will be paid by the Mare Owner.
- 3) By signing this contract, I the Mare Owner, agree to all terms thus making this a binding contract. It is the Mare Owner’s responsibility to MAKE A COPY of this contract for their own records.
